I understand that the sports of skiing, snowboarding and other recreational activities involve inherent and other risks of **INJURY** and **DEATH**. I voluntarily agree to expressly assume all risks of injury or death that may result from skiing/snowboarding use, or which relate in any way to the use of this equipment.

**I AGREE TO RELEASE** the ski/snowboard shop, it's employees, owners, affiliates, agents, officers, directors and the manufacturers and distributors of this equipment (collectively "**PROVIDERS**") from all liability for injury, death, property loss and damage which results from the equipment user's participation in the sport of skiing/snowboarding use, or is in any way related to use of this equipment, including all liability which results from **NEGLIGENCE** of **PROVIDERS**, or any other person or cause.

I further agree to defend and indemnify **PROVIDERS** for any loss or damage, including any that results from claims or lawsuits for personal injury, death and property loss and damage related in any way to the use of this equipment.

This agreement is governed by the applicable law of this state or province. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.
